05. The institution shall keep the Examination Hall/Laboratory and other material/furniture at the disposal of the Board as and when required, failing which their affiliation with the Board may be cancelled.
06. All the Recognised institutions shall recommend the books published and prescribed by the Board.
07. School shall deposit the Board fee without fail within the stipulated time.

Further, the schools which have not been considered for upgradation/extension their provisional affiliation shall automatically terminate on the expiry of the current academic session 2008-09 and they need to put up fresh application for upgradation of further extension in th period of Recognition/Affiliation..
